1 WHEREAS, A caring and purposeful life drew to a close with the  
2 passing of Janette Kathleen Davis of Galveston on January 3, 2025,  
3 at the age of 60; and

4 WHEREAS, The daughter of Cheryl Brien and William Warren, the  
5 former Jan Warren was born in Fort Worth on October 18, 1964; after  
6 graduating from Southwest High School, she earned a bachelor's  
7 degree in forest management from Stephen F. Austin State University  
8 in 1986; and

9 WHEREAS, A dedicated environmental advocate, Ms. Davis  
10 worked for the Texas A&M Forest Service for 17 years, beginning in  
11 its oak wilt program in Granbury and later leading rural assistance  
12 programs and addressing forest policy issues at the agency's  
13 headquarters in College Station; she went on to join the U.S. Forest  
14 Service, where she eventually served as deputy regional forester  
15 for the Southern Region of State, Private, and Tribal Forestry; at  
16 the time of her passing, she was a program manager for the Wildfire  
17 Risk Reduction Infrastructure Team, a committee created to prevent  
18 and manage forest fires in the western United States; and

19 WHEREAS, Widely respected by her colleagues, Ms. Davis was  
20 instrumental in moving the Society of American Foresters annual  
21 convention to Fort Worth; the recipient of a number of professional  
22 honors, she was especially admired for her great commitment to the  
23 preservation of woodlands and to mentorship; a devoted mother to  
24 her son, William Warren Davis, she enjoyed hosting friends and

1 family at her home, gardening, and attending live events; her life  
2 was further enriched by the companionship of her cherished  
3 Doberman, Abba, with whom she spent many happy hours walking on the  
4 beaches of Galveston; and

6 woman's love and friendship will always remember her with great  
7 admiration and affection; now, therefore, be it
